

## ABSENTEE BID FORM

1. All bids will be executed subject to the Terms and Conditions of Sale. The Absentee Bid is **irrevocable and non-cancelable**. All items are sold "AS IS, WHERE IS" without guarantees of any kind. It is your responsibility to inspect all items prior to your placing the Absentee Bid. ALL SALES ARE FINAL. Heritage Realty & Auction Co., Inc. offers this service as a convenience at no charge to their customers and will not be held responsible for error or failure to execute bids.
2. By placing the Absentee Bid, you are authorizing the Auctioneer or other Representative to bid on your behalf up to the limit of your bid. Absentee Bids are executed in competition with the audience, on an alternate basis. Due to the uncertainties of bidding patterns, the audience may win a lot for the same amount authorized by an Absentee Bidder. A (+) sign to the right of bid amount will authorize the Auctioneer/Representative to bid one additional bid. The Auctioneer/Representative will purchase your item(s) at the lowest possible price below your maximum bid. The Auctioneer/Representative reserves the right to advance your bid at the going increment. In the event of identical bids, the bid received first will take precedence.
3. If your Absentee Bid is successful, you will be contacted immediately to arrange for pick-up. Your credit card will be charged or your blank check completed. If a cash deposit was left, the remaining balance is due immediately.
4. Any applicable sales tax or Buyer's Premiums are not included in your Absentee Bid amount and will be added to the final bid to obtain the final selling price. A 25% deposit or signed blank check will be required if credit card information is not given below. For your security, your credit card information will be shredded as soon as possible.
